- Α. **DESCRIPTION OF CHANGE:** 
  - NYSEFC review of the January 2023 Engineer's Report requires the report to be updated to the most recent NYSEFC Engineering Report format. Comments were originally provided via an email on October 11, 2024. This email requires the report to be updated to the requirements of the "Engineering Report Outline for NYS Wastewater Infrastructure Projects dated October 1, 2023." EFC confirmed that even though the January 2023 report pre-dates the standards referenced in their comments, that the report is reviewed for the standards in place when the review occurs.
  - Since October 11, 2024, NYSEFC has issued yet another update to the Engineering Report Outline, dated October 1, 2024. This is the current report outline that is in place. Therefore, the January 2023 Engineer's Report will be updated to reflect the requirements of the October 1, 2024 report outline.
  - In addition to updating the January 2023 report to reflect the latest Engineering Report Outline, 0 the specific comments from the October 11, 2024 comment email from EFC will be addressed.
