- 1. The project is before the Board for a Clearing and Grading Permit under Chapter 83 of the Town Code.
- 2. Review of web-based photos available identify that the project site has trees in the area proposed to be graded. If trees still exist compliance with the Towns Tree Preservation Ordinance should be documented.
- 3. Filling greater than 1500 cubic yards requires the Building Department refer the application to the Planning Board. The project plans identify 7,987 cubic yards of fill proposed to be placed. Chapter 83 of the Town Code requires any fill activity in excess of 3,000 cubic yards have a Public Hearing scheduled through the Planning Board process.
- 4. Initial notices must be sent out to all property owners within 500 feet.
- 5. Filling is proposed up to the property lines. It is recommended that additional erosion sediment control be placed between the property lines and fill activity. Slopes proposed for filling may allow larger rocks within the fill to pass the property line.
- 6. The applicant's representative are requested to evaluate the grades of the stabilized construction entrance.
- 7. Highway Superintendents comments on the proposed location of the stabilized construction should be received.
- 8. Inverts for proposed driveway culverts should be depicted. Discharge of the driveway culvert should be addressed based on down gradient slopes. Additional erosion sediment control and/or level spreaders should be incorporated in the plan.

9. It is requested that the slopes between the 90 and 60 contour be identified on the plans. Specialized erosion sediment control techniques will most likely be required to stabilize the slopes. Erosion control matting or other erosion sediment control practices should be evaluated.

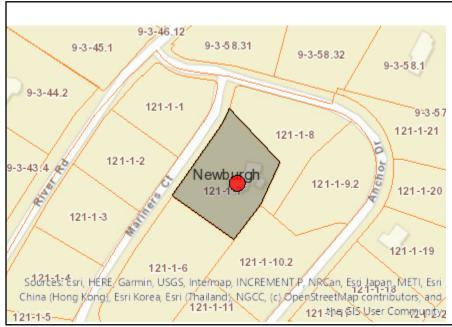
