RE: Environmental Review – EAF Part 2 – Monticello Raceway Management, Inc. Petition to Amend Zoning Code, Site Plan and Host Community Benefit Agreement

Dear Supervisor Piaquadio and Town Board Members,

In advance of Monday's meeting please find the full environmental assessment form (EAF) Part 2 prepared by this office as part of the State Environmental Quality Review (SEQR) process. Part 1 of the EAF was submitted by Monticello Raceway Management, Inc. (the "Applicant") with their initial February 26, 2021 submission package. The Part 2 is intended to assist the Lead Agency in evaluating the potential impacts of the Proposed Action (zoning amendment, site plan and Host Community Benefit Agreement). Along with the EAF Part 1, the Town has been provided additional materials by the Applicant (e.g., site plans, traffic reports), review memoranda from Town consultants, public input and input from the various Interested and Involved Agencies such as the Town of Newburgh Planning Board.

The Part 2 Form includes 18 categories of relevant environmental topics and first asks the reviewer if there is a potential impact in a specific area. If yes, there as a series of subsequent questions to determine if there is: no, of small impact; or, moderate to large impact. In making these determinations SEQR suggests that questions be answered in a reasonable manner considering the scale and context of the proposed action.

After a review of the Part 2, it is the Lead Agency's responsibility to prepare EAF Part 3 which will address those impacts identified during the Part 2 review. The discussion of impacts and mitigation will form the basis for the Town Board, acting as Lead Agency, to make a Determination of Significance. A Negative Declaration concludes the environmental review process, a Positive Declaration would require a subsequent environmental review as part of an environmental impact statement preparation.

In reviewing the EAF Part 2, the Town Board may also refer to the following link, <u>Part 2 - Identification of</u> <u>Potential Project Impacts (FEAF) - NYS Dept. of Environmental Conservation</u>, which provides some additional guidance on review and response to environmental topic area.

- The reviewer is not expected to be an expert in environmental analysis.
- If you are not sure or undecided about the size of an impact, it may help to review the sub-questions for the general question and consult the workbook.
- When answering a question consider all components of the proposed activity, that is, the "whole action".
- Consider the possibility for long-term and cumulative impacts as well as direct impacts.
