- 1. The project proposes a 4-lot subdivision consisting of 27 +/- acre parcel of property in the AR Zoning District.
- 2. Conceptual lot layout plan has been submitted.
- 3. Driveway locations on Candlestick Hill Road should be reviewed by the Highway Superintendent.
- 4. A portion of proposed Lot 4 extends into the paved surface of Candlestick Hill Road. A dedication of this land should be requested.
- 5. The EAF identifies 1.43 acres of disturbance. The project requires coverage under NYSDEC Construction Stormwater Permit. Future submissions should incorporate topography and a grading plan to delineate limits of disturbance.
- 6. A common driveway is proposed to serve proposed Lots 2 and 3. Common Driveway Access and Maintenance Agreements will be required. Grading plan for the common driveway must be provide.
- 7. Design of the proposed subsurface sanitary sewer disposal systems is required.
- The rear of the subdivision abuts the Ulster County / Town of Marlborough line. Submission to Orange County Planning upon receipt of a complete application and notification to the Town of Marlborough is required.
- Federal wetlands are identified on the site. Project should be submitted to NYSDEC to determine jurisdiction over the wetland areas. Recent changes in the wetland regulations require a preliminary screening by NYSDEC to determine if a well exercised jurisdiction over what is formerly federal jurisdictional wetlands.

- 10. The EAF identifies the project as 27-acre parcel. The application identifies the project as 26.9acre parcel. In the submitted subdivision map identifies it as a 25.5742-acre parcel. These should be corrected and be consistent.
- 11. Lot 2 proposes a flag lot. A very narrow strip is proposed for driveway access from the flag pole to the lot. This should be dimensioned.
- 12. Adjoiners Notices must be sent out.
- 13. The Planning Board may wish to declare its intent for lead agency for SEQRA review.


